**Chairman's Report**

As the cost of living crisis begins to bite across the nation it is important that we – as a parish council – do what we can with the Village Agents and other relevant agencies to support vulnerable parishioners. Everyone in the parish is urged to keep an eye on potentially vulnerable neighbours and anyone can approach our Village Agent, Izzy Sylvester on [07931 018045](tel:07931018045), should they need support.

Policing in the parish continues to be a concern with fewer police officers and PCSOs across the area generally. Although crime remains comparatively low in the parish (with the exception of crimes from unsecured barns and sheds) we cannot be complacent and hope that Sue Thompson's successor will come along to parish meetings to keep us abreast of current issues.

The other pressing issue within the parish remains poor internet speed and connectivity. This was discussed at the November Exmoor Consultative and Parish Forum (details of which appear elsewhere in these minutes) and further information may be found in the notes from that meeting.

**Dunster Panel** – it was noted to continue to seek the reinstatement of the Dunster Panel which is a vital link for communication in the area.

The meeting was held on November 17<sup>th</sup> 2022 at Dulverton.

The main focus of the meeting was the poor internet service across the area and this was highlighted in a question from the floor referring to Bury but equally relevant within our parish. A presentation by Matt Barrow (Stakeholder Engagement Officer) from Connecting Devon and Somerset (whose presentation can be seen at [https://www.exmoor-nationalpark.gov.uk/\\_data/assets/pdf\\_file/0031/453919/ECPF-17th-Nov-22.pdf](https://www.exmoor-nationalpark.gov.uk/_data/assets/pdf_file/0031/453919/ECPF-17th-Nov-22.pdf)) outlined what had been achieved but offered little information about areas not covered by the immediate roll-out. Nothing appears to be happening in our parish although Monksilver does appear to be an area due for upgrade imminently.

Nothing else was relevant to our parish.

#### Exmoor Consultative & Parish Forum

There was very little in the topics covered that relate to the needs of a rural parish like Nettlecombe

##### Highways

The reported pothole was repaired very quickly, unlike the gap near the Old Rectory which took 2 months' response time. The mud caused by surface run-off onto Clitsome Lane has also been raised today with an incident number. There are two further potholes to be reported – one between Vemplett's Cross and Egypt and the other between Vemplett's Cross and Wood Advent – which is of a serious concern.

##### Planning

An application was received from Guernsey Cottage in Woodford, opposite the turning to Nettlecombe Court. Three Councillors attended site to review the application for replacing a collapsed barn with a modern unit, and a 2.7 metre retaining wall halfway up the bank, with improvements to the access, which is currently very poor. There are no real objections to the building, but in a letter to the Council it was pointed out that the site was very steep and no mention has been made to the drainage, and potential build-up of water behind the wall. Also that no indication has been made for the building site drainage to avoid water running in from the retaining wall. There is no mention of rainwater drainage from the roof, and at the site meeting the applicant mentioned a soakaway will be made, but this could be difficult due to the steepness of the site. Also concern was raised for the floor of the new building, as there is an increased risk of run-off from a concrete floor, which would not be appropriate. Finally concern was raised for the asbestos content of the existing barn roof sheets and limited access to site for safe disposal. Concern was raised regarding the history of run-off and stoney debris onto the road below, as also raised by local residents previously. The drainage adjacent to the shared access requires upgrading to improve this situation. There was a retrospective request for site works already carried out. Tree and shrub plantings are essential on the steep slopes of the bank to counter water run-off and land slippage.

As no measurements were given of existing roof and eave heights it was not possible to draw a direct comparison between proposed and the existing building.

An application this week has come in from Exmoor National Park for the listed building at Huish Barton Farm. The alterations to remove some stud partitions in the farmhouse are entirely internal having no external impact, and therefore requires no involvement from the Parish.

Despite Planning Consent being given the Blade Mill remains untouched over the winter months.

#### Footpaths

**West Somerset Flood Group**  
There was a television News item recently and an article in the Exmoor magazine regarding improving Porlock's flood management scheme on the Holnicote Estate. The concept is good but putting it into practice seems to not follow the seasons for successful planting and establishment to be achieved.

Marilyn reported the leaky dams on Huish Barton farm are very silted up and the volume of water this winter has gouged out a deep channel. Caroline will follow up with Justin Nichols, the new owner, for a follow-up report.

The Roadwater Flood scheme established a few years ago has been very successful but keeping it maintained is still a problem.

The Chairman confirmed that it was not necessary to adopt the role of Flood Warden but merely the liaison Councillor to report back to the Parish Council. Caroline will remain the point of contact for the Parish Council.

Caroline attended the last Flood Group Meeting in December, with an interesting talk from the Wessex Flood Resilience Engagement Advisor – Tiffany Tapper. There is a useful flood incident helpline - **0800 807060**

There is also a grant available for flood equipment in communities up to £5000, but it was not thought that the Parish required specific support. After the heavy winter rains even Yarde fared well.
